#### **POSITION SUMMARY:**

This position supports the work of the Y, a leading nonprofit committed to strengthening community through youth development, healthy living and social responsibility. Provides direct leadership to plan, direct, and supervise programming for the CJ Sprouts program for 5-6 year olds.

### **ESSENTIAL FUNCTIONS:**

- 1. Assist with leading, planning, preparing, and general CJ Sprouts program operations, including staff training, in accordance with Camp Jorn guidelines.
- 1. Create organized spreadsheets for weekly activity schedules, group placements, time off, bus duty, cleaning assignments, and other schedules as necessary.
- 2. Supervise, provide guidance, and be a resource to counselors and program staff by being attentive, present and available for check-ins.
- 3. Uphold and maintain Camp Jorn, YMCA, ACA and DCF licensing standards in regards to camp activities.
- 4. Plan and lead an engaging all-camp activity each day. Delegate staff roles in all-camp activities.
- 5. Plan and lead the opening and closing ceremonies.
- 6. Ensure the appropriate preparation and clean-up of equipment and activity spaces.
- 7. Provide a safe, high-quality environment for all campers and staff through maintaining compliance with program policies, procedures and schedules.
- 8. Evaluate counselors and activities, and provide feedback.
- 9. Work with program staff, Resident Program Director and Day Camp Director to determine and fulfill supply and inventory needs for programs and activities.
- 10. Work with the Operations Director to plan and lead emergency procedures.
- 11. Build effective, authentic relationships with campers, families and staff; helping them connect with each other and to Camp Jorn YMCA.
- 12. Communicate important information with families as needed.
- 13. Oversee and coordinate check-in and check-out procedures.
- 14. Other duties as assigned.
