### **POSITION SUMMARY:**

This position supports the work of the Y, a leading nonprofit committed to strengthening community through youth development, healthy living and social responsibility. Provides leadership to coordinate, maintain and instruct the Sailing program, including daily classes and activities.

### **ESSENTIAL FUNCTIONS:**

- 1. Oversee the program of Sailing, including leading, planning and instructing classes and activities in accordance with Camp Jorn guidelines.
- 2. Provide a safe, high-quality environment for all campers and staff through maintaining compliance with program policies, procedures and schedules.
- 3. Ensure safety through regular maintenance checks of boats, equipment, docks and facilities. Repair and restock equipment as needed, in partnership with the Property Manager.
- 4. Ensure cleanliness and organization of docks and equipment. Keep a detailed inventory of equipment.
- 5. Develop and implement detailed lesson plans for Sailing classes tailored to learning objectives, with a focus on skill progression, safety and confidence.
- 6. Supervise and provide guidance to lifeguards, program staff and counselors.
- 7. Drive a motorized rescue boat to safely assist campers and/or tow sailboats on the water.
- 8. Be an active member of the Lead Team assist and participate in special programming, evening activities, counselor coverage and opening/closing day events.
- 9. Build effective, authentic relationships with campers; helping them connect with each other and to Camp Jorn YMCA.
- 10. Perform Other duties as assigned, including but not limited to: Kitchen and dishwashing assistance, general maintenance, camp beautification, cleaning bathrooms, lifeguarding, etc.

- 6. Proven leadership ability with organizational skills and a talent for supporting others.
- 7. Ability to observe camper behavior and apply appropriate behavior management techniques.
- 8. At least 21 years of age is preferred.
- 9. Ability to build relationships with campers, parents and staff.
- 10. Ability to accept guidance and supervision.
- 11. Good character, integrity, creativity and adaptability.

- Ability to work in loud, high-energy and at times overstimulating environments.
